***House/Grounds Maintenance fees due for non-docking members who joined after 2010 and for all docking members.**

A 2019 commitment and dockage form needs to be submitted by January; otherwise, WCYC will not be able to lift your boat in the spring. If you are not returning, you will need to make alternative arrangements to lift your boat at your own cost in a timely manner (e.g. with Southshore next door).

In consideration of like payment of other members of West Channel Yacht Club, I do hereby agree to pay the total dues, services and fees shown above for calendar year 2019.

In consideration of West Channel Yacht Club furnishing me with dockage privileges and club facilities at 35817 Lakeshore Blvd, Eastlake, Ohio 44095, I agree to carry Liability and Property Damage Insurance on my boat and dockage area in an amount NOT LESS THAN \$100,000 and agree to furnish acceptable evidence of insurance yearly with no exception. I further agree that my guests visiting at said club facilities will be my responsibility and that I shall hold West Channel Yacht Club harmless from any and all suits that may arise as the result of any actions on the part of myself and/or my guests.

In further consideration of like actions by the members of West Channel Yacht Club, I agree that I will have my boat either in the water or in a summer storage area designated by the club no later than June 15th. In the event I have not complied with any provision of this contract, then I waive all further notice by the club and assign to the said club the right to move my boat to a said storage area and further agree to become personally liable for any and all costs of said removal. Furthermore, I include the right of the club to place a lien against my boat if I should fail to pay any of the dues or other charges.
